NOTIFICATION

In exercise of the powers conferred on it by Section 91 read with Section-181 of the Electricity Act, 2003, (No.36 of 2003), the Rajasthan Electricity Regulatory Commission after previous publication hereby makes the following regulations, namely: -

GENERAL

1. Short Title, Commencement and Scope:

1. These Regulations may be called the "Rajasthan Electricity Regulatory Commission (Service)(Fifth Amendment) Regulations, 2019.
2. These regulations shall come into force from 1.1.2019.

2. Definitions:

In definition 1(b) the words "Commission in respect of posts specified in part I of appendix A and Secretary in respect of posts specified in part II of appendix A" shall be replaced with the words "Commission or Secretary as mentioned in the order issued by the Commission from time to time."

3. Amendment in Regulation 4:

In regulation 4(1) the words "Appendix -'A'" shall be replaced with the words "the order issued by the Commission from time to time."

4. Amendment in Regulation 5:

In regulation 5(4) the words "Appendix -'F'" shall be replaced with the words "Appendix -'1'".

5. Amendment in Regulation 7:

Regulation 7(1) the words "Appendix -'A'" shall be replaced with the words "the order issued by the Commission from time to time"..

6. Amendment in Regulation 8(1):

In regulation 8(1) the words “in Part-I & II of Appendix -'A’” shall be replaced with the words “in the order issued by the Commission from time to time.”

7. Amendment in Regulation 15 :

In regulation 15 the words “in column 5 of Appendix -'A’” shall be replaced with the words “in the order issued by the Commission from time to time.”

8. Amendment in Regulation 18:

In regulation 18 the words “in the Appendix -'A’” shall be replaced with the words “in the order issued by the Commission from time to time”.

9. General:

The words “Appendix-B”, “Appendix-C”, “Appendix-D” and “Appendix-E” wherever appearing in the Regulations shall be replaced with the words “order issued by the Commission from time to time”

10. Amendment in Appendix

(i) Appendix-A to Appendix-E shall stand deleted .

(ii) “Appendix -'F’” shall be renamed as “Appendix -'1’”.
